Along Comes Mazzuchelli & the Israelis.

It was the beginning of February of 1996. Mazzuchelli called his ILLION's hot line to say he wanted to come by and drop off his membership application. I gave him directions to the house where he could come by and drop off his application.

When he knocked at the door, the three dogs greeted him with a series of barking. I answered the door and he came in and the two went into the kitchen where we sat down over coffee.

At these and several other meetings Mazzuchelli would tell me something of his background.

He was a Marine during the Viet Nam War and was a Black Beret Marine (Special Forces)

He spent two years in Japan studying the Martial Arts at the Tokyo Dojo where attained the rank of 2nd degree Black in Karate and Ju-Jutsu.

He had been a member of the Bayan's motorcycle gang and had lived a life as that of a outlaw biker.

He also told another of facts that he had had several brushes with the law as a youth and done upstate time where he had spent some 3 years in prison.

He also told me he had many contacts

initial law enforcement. That his closest friend was a Treasury Dept Agent and the other the Lieutenant in charge of the Suffolk County Police's Narcotics Division -

I was also informed by this man that he connections to the mob through his uncle Mike who was the head of the Columbus crime family.

During the many times that I talked to Mazzaelli I got the impression that he was more than what he was telling me. I could tell he was a bullshit artist and he also had a penchant to lie. What made me suspicious that he was more than what he said he was. He struck me as a very ~~an~~ educated man with a very good ability to manipulate people and events to his advantage.

I also sensed that he was something other than what he was. From my training and instincts began to emerge that this man was something more than what he said he was. He was somebody's agent.

I felt I would play along and see where it all went. I knew there had been an attempt on Preston Nichols life in Sept, that at least three times I suspected someone had been in my house and the strange occurrences on the cruise the past summer. I would wait and see what happens.

After our first meeting; Mazzaelli wanted to become an investigator for the

organization. After meetings with him I gave him odd jobs to do for me. One was to travel over to Gary and Dotties Trott's office in Amherstburg to pick up a camera and a telephone tap detector I had left with them and also to learn of the whereabouts of Patty McDonald who had left their office after a very fatal head traffic accident.

I was pleased this time that I also met Mazzuchelli's friend Sal Maravaro who was his side kick and good friend. We met several times in Maumville on the 5th Avenue where we would have lunch. He was another auto mechanic and was a photocopier technician for a local company in Mastic. They were both divorcees who had lost every thing from their separations. They shared a room at the home of one of Joe's old girl friend's home. where they also worked on cases for extra money.

It was about the second week into February when I received a phone call from Mazzuchelli that he had talked to an old biker friend of his who owned a home near Southaven Park and saw the crash of the Bepet in the park. It was allegedly discovered by this man who made it into the park before the Police arrived and was later questioned by the Police who let him go. His motorcycle club name was rocket and he was willing to give a taped statement to the organization as a personal favor to Joe.

I would have to wait a week, because he was going out of town for a week long trip.

It was about this also that Mazzuchelli and his friend Sol borrowed my 1983 diesel engined Mazda Pickup to travel down to Tennessee to retrieve Toe's girl friend's possessions from her former boyfriend's home outside Nashville.

When Mazzuchelli called about Rocket, he was still using my pickup which he said he would return by the 23rd or 24th of March. On the 23 of February we all would meet at the denver on Rte 11 at 10AM with Rocket to discuss his testimony.

On the night of February 22nd, a Friday, I was home, but had places to watch the Outer Limits with Zappado which I later canceled, when about 11:00 PM I received a phone call from Mazzuchelli.

It was answered by the answering machine and since I was preparing for bed didn't bother to review it until the morning. About 9:00 AM the following morning Mazzuchelli called telling me to cancel the planned meeting since he had been attacked by four men who had pulled the truck over to the side of the road on the LFE entrance ramps on N Ocean Ave. and dragged ~~the~~ him out of the truck, beating him badly. The ominous threat was left with Toe, "Stay out of our business or the next time we'll kill you!"

I was stunned. One of our members had been openly attacked and beaten. My mind raced back to last May when the Northeast Director had visited me and the warning he had left me with. It had come true.

But what had happened sent shivers down my spine. He was driving my truck and what if it was a case of mistaken identity which meant the beating was meant for me. I intended that evening to call my old friend the Northeast Director at his home in New Jersey.

Arriving that afternoon (I never kept the appointment for breakfast at the diner) at my home Mazzechelli appeared to return the truck and to have me drop him off at his golf friends. His face was a mess from the beating, plus he had substantial bruises all over his body.

Mazzechelli flatly refused to report the incident to the Police and in addition vowed vengeance for what had happened. He did allow me to photograph his injuries and I filed a statement on the incident for our files. The statement I had him swear to while I notarized it.

He did say he would take a minute and talk to Bryan Ward of the South Shore Press whom I called to report the incident to and to whom Mazzechelli retold the story to.

Mazzechelli left my home vowing to have his Uncle Mike take vengeance against the four. He sounded like he meant it.

I called the members of ITALION's executive committee and advised them of what happened and warned them to take precautions. The threat had grown to be real and where and when the next strike that would occur no one could predict.

late that night I called the North East Director and restated the events as they were described to me. I asked him to do a favor and find out what he could. He told me to be careful and he would be back to me in a week,

That weekend I contacted Preston Nichols who was as concerned as I was about the incident. He expressed the opinion that the attack may have been meant for me since Joe was driving my truck. He left me with a promise to consult with his friend in Air Force Intelligence about the incident. He would get back to me if he learned anything.

That week Mazzuchelli dropped by in a state of rage, ranting how he wanted to kill the four individuals that had attacked. He related how he had talked to his uncle Mike who was furious (Mazzuchelli's father was a Capo in the family and when he died asked his brother Mike to look after Joe) and had vowed to do whatever it took to get the four perpetrators.

I asked Mazzuchelli on Tuesday to come to a meeting with Preston Nichols to see what Preston had learnt. Meanwhile Tom reported his Uncle had sent word to the politicians

To keep their hands off Mayzachello and all the members and leadership of H.I.M.P.O.N.

Tuesday afternoon we met Preston at the Diner on Rte 12 in Medford. He had met with "Dan" and had information. He showed us a list of four names of individuals who Dan said were known to his intelligence group who worked out of Brookline Habs and were used as goons to intimidate LPD witnesses. Preston further related that there was a rule called that all involved were told to stay out and away from H.I.M.P.O.N. Mayzachello chimed in that this meant his uncle and was precisely what his uncle Mike had instructed the politicians.

I and Preston left the diner along with Joe who I left by his girlfriend's house. I was going to call the Northeast director and find out who or what was going on. I wanted to know if these four were the goons described and who sent them. Who was next on their list?

My call to my old comrade was never to him at his job. He acted as though the phones may be tapped his statements were short and to the point. He advised me he was going to run the names and see what he could find out. He advised me to stay put and don't do anything to break the law.

In the meantime I began to run the names myself. I called Blackhandus in Brookly P, our County chairman, to ask him to run the names through his computer to come

up with phone numbers and addresses. He completed it in about an hour we had their addresses and phone numbers.

I then began over the next two days to call these people and pretend that I was a salesman. I found to my surprise they were all retired personnel from Brakeliner busses. All were in advanced ages and were not likely to chase cars off the road and beat people up. Dan's info was a dead end.

Mezzuchelli came by and he continued his haranguing about seeking revenge and getting the people who had attacked him.

He informed me that his uncle was working through local politicians to find the person who originated the contract and the people who did the job.

Mezzuchelli talked about kicking these people if he got his hands on them. He also talked about having his uncle have them killed. He talk reprelsed me so that I politely asked him to leave my house.

The next evening the Northeast Director informed me he had been a close friend to the victim and could provide no answers to me; He did say one thing, that he would see to it that protection was on its way. What did he mean by that?

Mazzuchelli Gets Arrested.

It was very shortly after this that I got a urgent call from Mazzuchelli from the Suffolk County Police's Fifth Precinct to notify me he had been arrested on a 1992 warrant for burglary which he said he didn't do. He was to taken to arraignment and from there he would most likely go to the County jail.

He called me late that night. He was now arraigned on a \$1000 bail and was at the county jail in Yaphank. He was persistent in that he kept calling asking to be bailed out and that he was afraid he would be killed in jail since he came from the botting there was a contract on him.

I called Zuppardo to see if he could help with raising the bail, but he has low funds and was unable to help. Between Preston Nichols and myself we raised the money and managed late that night to get Mazzuchelli out of jail.

When we did, he immediately on the way to my house centered in his fear of a contract being on him because according to him the arrest was a frame up. At the time the burglary was committed, he was in New Mexico, therefore he could not have perpetrated the crime - I allow him for his safety to stay at my house for a few days until he felt safe to go up to his girl friend's and pick up his car.

I was still & truly surprised that this man was scarcely 5'6" & 150 lbs. I wanted to see where developments led.

There was another meeting shortly after this where we have Peruvian UFL Researcher Percy Malone address the group. I had sent a letter to all the members that addressed the issue of Mayzchallo's beating. At the end of the meeting when he was supposed to speak he got up and left the room embarrassing me in front of the membership. Although the majority of members expressed shock and alarm at the event, they were equally puzzled as to why he refused to speak.

This now unto the beginning of the month of March. One afternoon Mayzchallo and Sal dropped by to talk. Joe mentioned his uncle like wanted to meet me and thank me for helping to watch out for Joe. I was to have a meeting with his uncle that night and to be ready at 8:00 p.m. for a limousine to take me to his home in Brooklyn.

After Joe left I called Steve Tavares, and Tony West to advise them of the situation. They expressed fear for my safety along with Preston Nichols who I called also for his opinion. That night at 8:00 p.m., no limousine showed up and no uncle like.

When pressed for an explanation, all Mayzchallo could tell me was that his uncle was under Federal surveillance and had to break off the meeting. It would be rescheduled. It never was. Also his friend "Rocket" had disappeared to a lake valley in Florida and was at his engine hiding out from whoever was behind the contracts.

It was local Politicians

This afternoon Mozzuchelli dropped by to visit. He had received information from his Uncle as to the identities of the four individuals who had beaten him. The information, obtained from local mob and politicians, indicated the four were members of Brookhaven Public Safety and were hired not to beat up Joe. The hit was meant for me. I was shocked, but not surprised. I had suspected it because of my past knowledge and participation in local politics thru the NY State Conservative Party. Joe said not to worry his uncle had protection on me and I was not to worry protection was here. His Uncle was going to see to it that the four would receive their treatment and wind up in the hospital for a long time.

A few days later he would inform me business had been taken care of. I was not to worry. I felt sickened and repulsed at the way Mozzuchelli revelled in the thought of violence.

Shortly after the last meeting Mozzuchelli came over this particular afternoon. His car was at the friz and he asked if he could borrow my 1980 chevette until he could get his car back on the road.

As he sat down at my dining room table and began to speak I felt there was more to meet the eye than what he said he

excused to speak about. The car was an excuse. His friend Sal was outside waiting in his own car. I knew he had something to speak about.

He began the conversation talking about his uncle Mike. He said he voted that I did NOT approve of his Uncle's business and his ties to his Uncle's family. I agreed with him on that.

He said that it was a test to see if I would involve myself in criminal activity. He said I had a very strong moral character.

He stated in very simple words that he felt the two of us had become friends and he had talked to his superiors and they said it was alright to tell me since I had a need to know.

Joe Mazzuchelli said in very simple terms, "I am a Lt Colonel in Israeli intelligence (the Mossad) and we have been waiting five years to make contact and enlist you and IUPAN as a 41 nation intelligence Task Force to overturn the US Government's UFO Coverup."

I was left speechless. I was in stunned amazement. Now everything began to fit. The North East Section Director contacting me and showing the interest in UFOs.  - 5) He knew of my CIA background and the name of the Northeast Section Director of the CIA plus his predecessor's identity which was known to me.

I sat there in silence. I knew his credentials were in order, like the Northeast Section Director had said, protection would be in place as I would shortly learn.

Joe added to the tension in the room by stating, "We accelerated our efforts to contact you and enter you into our Network of Researchers because you have been targeted by local politicians through the agencies of the Federal Government to kill you."

I replied, "Does this have anything to do with the accident Preston had and the two accidents I had with my car?"

Joe answered, "Yes, they have targeted you because of the '95 Forest Fires."

Mazzuchelli stated that the 95 Forest Fires were the result of deliberate and intentional arson by public officials.

He began to tell me:

- 1) There was indeed a UFO crash that day. The object 120 inches in diameter along with a smaller disc shape object about 30 ft in diameter had crashed outside of his head. Patty McDonald and her friend Steve Ferrer were right.
 - 2) Suffolk County Bob Gaffney was contacted by the U.S. Government and asked to have the County Parks & Conservation Dept set forest fires around the crash site near Suffolk Community College Campus.
 - 3) Gaffney called County Republican Leader Tom Powell to ask him to have people ready to help set the fires. Powell contacted political confidant Anthony Gazzola director of Public Safety for Brookhaven Town and asked him to have his people and political hawks ready to set the fires.
- What happened now was very vague even Mazzuchelli was ~~not~~ too clear on the subject. Some where along the way either Powell or Gazzola got the idea or they took the initiatives to set forest fires south of Sunrise highway where the Government did not want set in populated areas.
- 4) The fires were set south of Sunrise to satisfy the investment desires and real estate greed of Catterson, Powell, Fred Toorl, and Carricola of Wading River. They hoped along with lesser political officials to gain control over real estate.

facts that they wanted to burn out and gain control off from their owners. They also wanted to make money on reconstruction of burnt out buildings and homes.

- 5) The public officials did not expect the fires to spread and go out of control so fast and did not anticipate the media attention both national and international. They had to undertake a master plan of deception and cover up to prevent the public learning of both the UFO crash and the deliberate arson.
- 6) The Political Powers in Suffolk were worried that both myself, Preston Nichols and LIUFON would investigate the crash and uncover the illegal land scams and learn the nature of and origin of the forest fires.
- 7) I and Preston Nichols along with the leadership of LIUFON had been targeted. The request had come from 6 members of the County legislature, John Powell, Bob Gaffney, Senator D'Amato and Gov. Pataki.
- 8) I was told that Gaffney, Powell, D'Amato and Pataki had been taken to the crash site and had seen both ships and alien bodies.
- 9) That the White House had sent the request for assassinations up to Majestic 12 which with Vice President Gore had organized them through Commerce Secretary Brown's direction. A number of other UFO Researchers nationally were also targeted because they were getting too close to gaining material that could prove the

existence of UFOs and threaten the coverups.
(It should be noted that MUFON member UFO network chairman Walt Andres confirmed that two statechairs of his organization died in least in car collisions around Tamayo February of 1996). Thus it was through the Commerce Dept (the main control apparatus for the UFO Coverup) that the contracts went out through Secretary Brown would later die in an air crash in Bosnia that year. It was reteleaction by the anti-coverups forces for the assassinations. He was shot down along with his party by a US Air Force F-16 equipped with a particle beam cannon. This explain the strange nature the wreckage would show of being more shattered than twisted from stress.

- 10) Israel and 40 other nations or their intelligence services have formed an international effort to topple the US Government's UFO Coverup.
